Introduction

<u>Aim</u>

Objectives

<u>Rationale</u>

Therefore, this particular study is focusing on investigating the efficiency of CLA for learning a foreign language.

Literature review

Learning foreign languages creates major challenges for individuals. This is because it creates doubt regarding abilities while learning about new languages. Leung and Valdés (2019) stated that language learning applications incorporate different features that alliance individuals for learning new languages. It is considered the presence of various techniques so that vocabulary can be learnt appropriately. Lack of practice opportunities is also a major hindrance that is generated. In this case, individuals can experience challenges while learning a new language due to a lack of opportunity. Onishchuk et al. (2020) stated that linguistic theory provides information about the linguistic knowledge that is required to be considered for mastering native language. It provides information about the behaviour and development of individuals. In this context, the consideration of different components associated with this theory can be valuable. This is because it can help in analysing the behaviour of individuals, that are valuable for understanding it. Moreover, Onishchuk et al. (2020) stated that fear of speaking with strangers and reduction of motivation are also considered major hindrances that are experienced by individuals. It is evaluated that CLA is important while learning a new language as it focuses on providing a real communication process. It considers the competence of learners for communicating in the targeted language. On the other hand, Makhmudov (2020) illustrated that this process does not focus on the acquisition of grammar and vocabulary. It mainly targets communicative competence with an enhanced focus on real-life situations.

The behaviourism theory of learning provides information about the interaction with the environment. It conveys knowledge about the influence of internal and external environments on the behaviour of individuals. In this context, Martin et al. (2020) mentioned that the consideration of the respective theoretical framework can be valuable for understanding external and internal injuries and behaviour. This can also facilitate understanding various communicative competencies that are valuable for maintaining the language of individuals. In this case, the consideration of various components of this framework can be fallible for understanding the language lack of understanding between individuals. Martin et al. (2020) added that an important feature associated with CLA is that it facilitates increasing the capabilities of learners to communicate in the target language competency. It is also considered one of the significant approaches that are involved in communication for generating natural

strategies for language acquisition. This particular aspect is valuable for learners to understand various aspects that are required to be incorporated for using the language. Liu et al. Methodology

Moreover, a deductive research approach and descriptive research design will also be applied in this context. A thematic data analysis technique will also be incorporated in this case. This will facilitate the researcher to generate different themes and codes that will be valuable for highlighting the inter-relationship between variables. It will also facilitate understanding the situation adequately.
